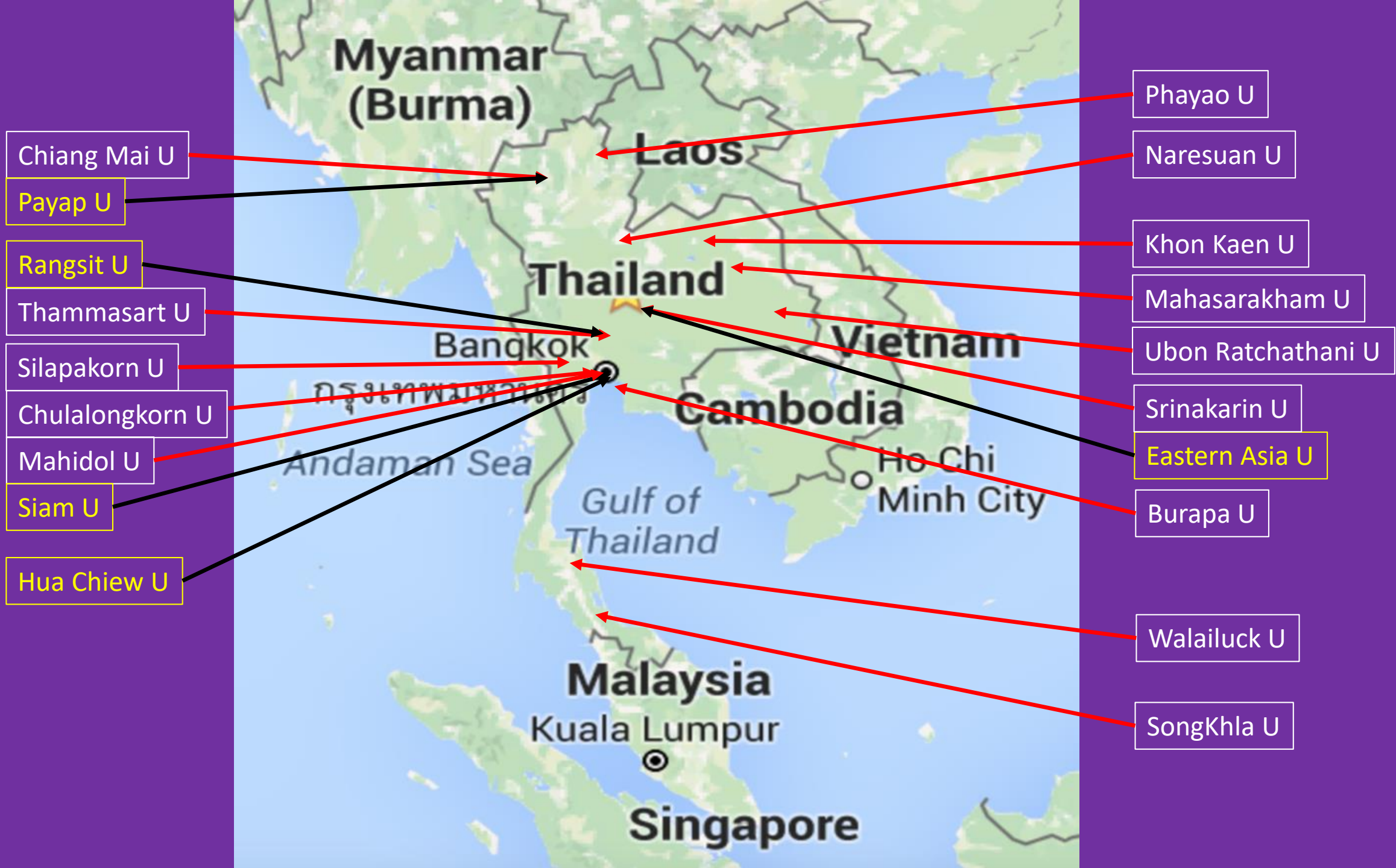

- ◎ 6-year Pharm.D with 3 areas of specialty
 - Pharmaceutical Care
 - Industrial Pharmacy
 - Consumer Protection
- ◎ Residency for post graduate training
 - College of Pharmacotherapy
 - College of Pharmaceutical and Health Consumer Protection
- ◎ License Examination
 - 4th year core knowledge
 - 6th year profession knowledge and skill
 - Continuing education 100 credits/5 years for relicensing since 2015
